P.A.S.S. Transfer Instructions

****P.A.S.S. Transfers are ONLY accepted between, November 10, 2017 and January 27, 2018****

- Season tickets and single day tickets **must be paid in full** prior to initiating the transfer process. Please do not mail the request form in before paying for the 2018 tickets, the transfer form may be discarded.
- Complete the Transfer Request form and return to KSC along with a copy of the account holder's photo identification. If **ALL** documents and fees are not received the request will be returned to the original P.A.S.S. holder (via US postal service) for completion.
- If the original P.A.S.S. holder is **not transferring all seats or transferring to multiple persons** there will be a \$15 handling fee requested at the time the Transfer Request form is turned in as well.
- A P.A.S.S. transfer of ownership contract is typed by KSC and mailed to original account holder.
- The transfer of ownership contract must be signed by **both** parties and returned to KSC in the allotted time as stated in the letter sent to the original P.A.S.S. holder.
- Transfer agreement is reviewed by KSC's Legal Department and signed by the president of KSC.
- Seats are transferred and copies of the transfer contract are mailed to the appropriate parties.
- Upon completion of P.A.S.S. seat transfer, the original account holder is released and forfeits any rights to the Founding Fan P.A.S.S. seats and relations.

This is a general overview of the P.A.S.S. transfer of ownership process. KSC reserves the right to amend or change this process at any time and for any reason.
